In case of late submission, Tenders will not be entertained.
- Each tender must be accompanied by bid guarantee of Rs.100,000/- in the form of Bank Draft or CDR payable at Multan in the name of <u>Finance Director</u>, <u>MEPCO HQ Khanewal Road Multan</u> otherwise tender will not be entertained.
- The successful bidder shall submit performance guarantee issued by any Scheduled Bank of Pakistan equal
 to 05% of contract amount, which will be valid for entire period of contract and will be forfeited in case of
 unsatisfactory services assessed through a committee constituted for the said purpose and ban will be
 imposed upon the service provider for its participation in future MEPCO Tendering for providing Courier
 services.
- The Bids should remain valid for 120 days and bid guarantee should remain valid till 150 days from the bid opening date.
