1. The District Health Office, Islamabad invites sealed bids for the **Procurement of Furniture & Fixture** under procurement reference Number: **PSDP/2024-25/002**.
2. Bidding shall be conducted under National Competitive Bidding through **Single Stage-Two Envelope Procedure**. Bidding Procedure is detailed in the Public Procurement Rules (PPRA Rules) 2004.

Eligible suppliers, original manufacturers and authorized dealers registered with Income Tax and Sales Tax Departments & are on Active Taxpayers List of the Federal Board of Revenue (FBR) and registered on EPADS of PPRA may download bidding documents in English from EPADS after payment of **Rs 5000/-** to the Cashier, Accounts Section, District Health Office, Islamabad G-9 Markaz during office working hours up to **(Date/Time)**. Original receipt must be attached with the Technical Proposal without which it shall be rejected straightforward.

The Vendors/Firms will drop original fixed bid security in shape of CDR / Pay Order of **at least one percent (01%)** of the total bid value in Pakistan Rupees in the shape of Bank Demand Draft, Call Deposit Receipt in the name of District Health Officer, Islamabad.
