### HIRING OF CONSULTANT/ARCHITECT SERVICES

Cantonment Board Nowshera intends to hire the services of well reputed consultant/ architect firms registered with PCATP and PEC as stand-by consultant for a period of one year (Extendable for another year, if required) for planning, designing and revamping/re-habilitation of its Cantt fund properties. The interested firms are required to submit their bids through SINGLE STAGE TWO ENVELOPES procedure as outlined in rule 36 (b) of the PPRA Rules, 2004. Each envelope shall contain separately the TECHNICAL PROPOSAL & FINANCIAL PROPOSAL and shall be marked as such in bold and legible letters to avoid any confusion. The bid validity period shall be ninety (90) working days after the bid is received and opened.

#### A. SCOPE OF WORKS:

1. Planning, designing and revamping/ rehabilitation of cantt fund buildings etc.
2. Preparation of BOQs on prevailing MES Schedule of rates.
3. Interior designing of cantonment fund buildings.
4. Hard & soft landscaping.

#### B. EVALUATION CRITERION:

The evaluation committee of CBN shall first scrutinize the technical proposal based on evaluation criteria described in bid documents while retaining the financial proposal.

#### C. FINANCIAL EVALUATION

Only technically qualified firms shall be called for opening of financial bid which shall be opened in the presence of the authorized representatives of the firms who wish to be present on the g given date and time.

#### D. SUBMISSION OF BIDS:

1. Closing date for bids to reach in the Office of Cantonment Board Nowshera is on 18.12.2024 at 11:30 am and only technical bids shall be opened on same day at 12:30 pm, while retaining the financial bids sealed, in presence of authorized representative of firms who happen to be present at that time. The bids received late will not be entertained.

2. Conditional/telegraphically dispatched bids will not be accepted.

3. Tender documents can be obtained from the Office of the Cantonment Board Nowshera during the office hours on payment of Rs. 1000/- (Non Refundable) immediately after publication of this notice.

4. The bids shall be accompanied by earnest money of Rs. 100,000/- in the shape Pay Order or bid bond in the name of Executive Officer, Cantonment Board Nowshera, and will be attached with Technical bid.

5. The quoted rates in FINANCIAL PROPOSAL should be free from any cutting, erasing and overwriting etc.

6. All those bidders who are black listed by any Government Department are not eligible for the bidding.

8. The lowest rates quoted in financial bid approved by the Board shall be valid for one year at least.
