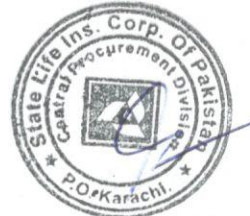

Delivery of printing items is required at State Life Insurance Corporation of Pakistan's Karachi Office, and printed stationery items required in good quality boxes.

- In English version each Rate Book consisting of 210 pages approximately + Cover, 47 pages will be recomposed by printer is also included in 210 pages. These recomposed pages must be vet from SLIC before printing of whole Rate Books. Pervious Rate Book version is available for scanning purpose.
- In Urdu version each Rate Book\_132 pages approximately + Cover, 24 pages will be recomposed by printer is also included in 132 pages. These recomposed pages must be vet from SLIC before printing of whole Rate Books. Pervious Rate Book version is available for scanning purpose.

### TERMS AND CONDITIONS

- 1- Bidders should provide the name of firm, complete address, Telephone No, Fax No, Email Address and web address (if any).
- 2- Bidder must visit office to see samples / specimens of Rate Books (English & Urdu) and additional pages before submission of bids on EPAD System.
- 3- The bidder will compose the soft copies of English & Urdu Rate Books and the same will be handed over to State Life for approval before printing process.
- 4- Bidders are required to upload their bids on EPADS system as per laid down PPRA procedure for single stage two-envelope method i.e separate "Technical Proposal" and "Financial Proposal" respectively and clearly marked as "**Printing of Rate Books (English & Urdu) Pertaining to Underwriting Division.**". However, bid security in shape of pay orders must be submitted at the address given in tender notice / document before closing time else tender will be rejected.

- 5- **The quantity of printing items may be increased / decreased at the time of issuing purchase order.**
- 6- All Bids would be evaluated item wise.
- 7- **As per EPADS format the financial bids of only those items would be considered against which technical bids has been uploaded on EPADS by the bidders.**
- 8- Initially only Technical Proposals will be opened and downloaded from EPADS on the opening date and time as given tender notice / document. Time and date for opening of Financial Proposals of technical qualified bidders will be announced after finalization of Technical Evaluation and will be announced on EPADS system accordingly.
- 9- There will be a two-stage evaluation of bids. Technical evaluation will be held first. Minimum overall 60% with minimum 50% in each of the four categories listed below is required for the bidders to technically qualify. Financial bid of only technically qualified bidders would be opened.
  - a) Details of type of printing machines (one color, two colors or four colors).
  - b) Whether have the in-house facilities of, i) film processing or CTP, ii) plate making or CTP, iii) cutting, iv) binding.
  - c) Number of years of experience in printing.
  - d) Number and nature of existing clients.

**NOTE: Facility of Standby Generator is a mandatory requirement.**

- 10- The Most advantageous Bid would be accepted.
11. Bid Security shape of Pay Order/Bank Drafts for Item No.01 of Rs.400,000/-, for Item No.02 of Rs.100,000/-, respectively, in favour of State Life Insurance Corporation of Pakistan as earnest money. The same will be returned immediately to un-successful bidders after completion of formal procedure and to successful bidder after issuance of purchase order / signing of contract. However, successful bidder will be required to submit performance guarantee of 2% (value of Job Order) in shape of bank guarantee (valid for entire time period of completion of job) in favor of State Life Insurance Corporation of Pakistan at the time of issuance of purchase order / signing of contact and will be released after satisfactorily completion of job.
12. No bid will be accepted without bid security.

13. All the bids must include G.S.T. and all other taxes, in case, these are not categorically shown, it is considered that quoted prices inclusive of all taxes.
14. **Bid validity:** The bids submitted shall hold good for a minimum period of 90 days from the date of bid opening.
15. If the successful bidder fails to supply the material as per purchase order, the performance guarantee will be forfeited.
16. Competent Authority reserves the right to reject all bids or proposal any time prior to the acceptance of a bid or proposal in the light of PPRA rules.

**TECHNICAL EVALUATION – POINTS SCORING CRITERIA / FORM**

	<b><u>Max. Points</u></b>
a) Details of type of printing machines i.e. one color, two colors or four colors. (Maximum 02 Machines in each cadre will be qualify to score points) 08 points each for four color, 04 points each for two color, 02 points each for one color machine.	28
b) Whether the bidder has the in-house facilities of i) film processing or CTP, ii) plate making or CTP, iii) cutting, iv) binding. (Six points for each facility).	24
c) Number of years of experience in printing. (Three points for each complete year. Minimum 5 years).	30
d) Number and nature of existing clients. (Two points for each Corporate/Multinational/ Govt./ Semi Govt. Organization).	18

**Note:** Minimum 50% score in each of the above categories with over all 60% score is required to qualify for financial bid.
