REQUEST FOR PROPOSAL APPOINTMENT OF COMMERCIAL AUDIT FIRM

Pakistan Water and Power Development Authority (WAPDA), an autonomous and statutory body which is mandated for development of Water and Hydropower resources under the administrative control of Federal Government, invites Proposals from the Commercial Audit Firms to provide External Audit Services for WAPDA Hydroelectric regulated business for the Financial Year ended on June 30, 2025 on general purpose framework.
