

The Bid Security/Earnest Money (2%) must be accomplished with scanned copy of CDR in the name of Divisional Accounts Officer, Pakistan Railways, Multan amounting to Rs.71290/-. Whereas, Bid Security in original shall be submitted in the office of Superintendent of Police, Pakistan Railways, Multan alongwith other necessary documents as stated in bidding documents and "Samples". The Bid/Tender must be uploaded on E-PADS on **24.04.2025 at 12.00 hours** positively. Technical bid will be opened on **24.04.2025** and Financial Bid will be opened on **30.04.2025**.

3. Only Bids through E-PADS will be entertained and no other Bid will be accepted except E-PADS. After opening "Technical Proposal" at 12.30 hours, the "Financial Proposal" will be opened in the chamber of Divisional Accounts Officer, Pakistan Railways, Multan in the presence of the Bidders or their authorized representatives on the same date.
