PUBLIC/OPEN AUCTION OF TEMPORARY STAGING STEEL ITEMS

1. National Highway Authority (NHA), Multan intends to dispose-off the following temporary staging steel items through Public/Open Auction method on **11.07.2024** “**As and Where Basis**”:

2. The above-mentioned steel items can be inspected on any working day up-to 10.07.2024. The Public/Open Auction will commence @ **1230 hours on 11.07.2024** at NHA Regional Office, Nag Shah Chowk (N-70), Multan.

3. Pay Order/Demand Draft amounting to **Rs. 1,500,000/- (Rupees One Million & Five Hundred Thousand only)** **in favor of General Manager (Punjab-South) NHA Retention Money Account**, should be submitted by each participant along-with copy of valid CNIC, as Expression of Interest/Token Money (**Refundable**) up-to 1200 hours on the day of auction; without depositing such PO/DD no person shall be allowed to participate in the public auction.

4. The successful/highest bidder shall have to deposit **25%** of the highest bid amount at the spot as earnest money (**Non-Refundable**), failing which the bid shall be rejected, token money of such bidder shall be forfeited and auction process shall be continued.

5. After auction, Pay Order/Demand Drafts of 1st, 2nd and 3rd position holder bidders shall be retained till finalization of auction process and others will be released under the stamp and signature immediately.

6. The successful/highest bidder shall have to deposit the balance amount within 06 (Six) days after approval of the highest bid by the Competent Authority. In case successful bidder fails to deposit the balance amount within the prescribed time, the token and earnest money of such bidder shall be forfeited. The Authority reserves the rights to offer the said steel items to 2nd highest bidder.

7. Successful/highest bidder will be accorded written permission for removal of above-mentioned items at his own risk & cost from the above-mentioned location within specified time after depositing full payment including all applicable taxes. If successful bidder fails to remove the items within specified time, ground rent per day @ 0.5% of the total bid amount shall be charged from the purchaser before said items are removed.

8. Government Taxes (whatsoever admissible) will be charged as per prevailing Rules, besides Bid Price separately.

9. Queries (if any) can be cleared at the spot, thereafter, no objection shall be entertained and decision of Auction Committee in case of any dispute shall be final.

10. NHA reserves the right to reject all bids in accordance with PPRA Rule No. 33(1).
