




**NOTE :-** Contractor shall provide certificate that they are not involved in any type of litigation with Government Department in the Court of Law and that no special report of Directorate of Inspection and Evaluation (E-in-C's Branch GHQ Rwp) is outstanding against them.

3. Firms/Contractors not borne on approved list of MES will furnish a certificate along with their applications, giving details of works executed during last two years and those in hand on the proforma appended below:-

4. All contractors, will certify in writing that they are registered with Pakistan Engineering Council (PEC), and will be submit a copy of their registration, Contractors not registered with PEC are ineligible to apply.

5. Contractor born on approved list of MES in Category "A", "B", "C" & "D" and also having experience of this type should only apply.

6. Contractor who desire may be present at the time of opening of tenders.

7. The accepting officer reserves the right to accept or reject the tender, Rejected tenders will be dealt with as per Para 33 (i) of PPRA Rules.
