1. National Highway Authority (NHA) invites sealed bids from eligible bidders who can prove their eligibility and qualification as mentioned in the Bidding Documents for the following work. The estimated cost and other brief of project is mentioned below:

2. Bidding will be carried out by adopting "Single Stage Two Envelope" procedure. Bidders are required to be registered with Pakistan Engineering Council with a valid registration Certificate in Category mentioned against each with specialization in CE-01 & CE-10 for the year 2020. Joint Venture (JV) of maximum Two (02) firms is also admissible; however, both of the firms forming JV must be licensed in a minimum Category as mentioned above.

3. Bidders can download bidding documents from NHA website. The bidders are advised to visit the site before submission of bids. Bids shall be received in NHA Complex Nag Shah Chowk Multan on 20th October 2020 until 1200 hours. Bidders' representatives would be required to present the "Authority to Submit the Bid" while submitting the bids. The envelope containing "Technical Bid" will be opened on the same day at 1230 hours in the presence of bidder's representatives who choose to attend. Second envelope containing "Financial Bid" of technically qualified bidder(s) will be opened later, the date of which will be communicated after evaluation of the Technical Bids.

4. Bid security in favor of National Highway Authority, Retention Money Account of an amount i.e. 2% of Engineer's Estimated Cost, in the form and validity as mentioned in the bidding documents, must be accompanied with "Technical Bid". All prospective bidders are required to provide the Audit Reports as per format uploaded on NHA website. All the bidders must fulfill the criteria mentioned in Tender Document Instruction to the Bidder's "**Bidding Data Sheet**".

5. The Bidders will provide the No litigation Certificate or information about any litigation along with Technical Bid. The Bidder representative would be required to present the **Authority Letter**.

6. The firms providing unsubstantiated and / or incorrect information are liable to disqualification and / or legal action. NHA reserves the right to reject all bids as per the PPRA Rule no. 33(1).
