## MILITARY ENGINEER SERVICES TENDER NOTICE

1. Applications for pre-qualification of contractors/firms are invited by the Garrison Engineer (Army) Pano Aqil Cantt for the issuance of tenders of following works in the light of PPRA Rules 33 (1) of 2004.

2. The contractors are required to submit their applications to Garrison Engineer (Army) Pano Aqil Cantt for issuance of tender documents alongwith their credentials as shown at ser 4 below. The applications shall be scrutinized and the tender docus will only be issued to the firms / contractors, who have sufficient experience in the relevant field and satisfy other special conditions required for the job and area. The sealed tenders will be received in the office of accepting officer by **14 Feb 2025** till 1130 hrs and will be opened at **1200 hrs** on the same date.

**Note:** Contractors shall provide certificate that they are not involved in any type of litigation with Government Department in the court of law and that no special report of DI&E (E-in-Cs Branch) is outstanding against them.

3. All contractors will certify in writing that they are registered with Pakistan Engineering Council (PEC) and will submit a copy of their registration. Contractors not registered with PEC are ineligible to apply. Contractors will have to submit fol docus:

- a. Copy of Enlistment Letter / Renewal Order
- b. Valid PEC Certificate / Renewal Application
- c. NTN alongwith "Active Filer Status"
- d. Professional Tax Certificate

4. Firm / contractors not enlisted with MES will furnish their applications alongwith statement of previous experience, giving details of works executed during last two years and those in hand on proforma appended below:-
