



Cantonment Board Peshawar a body corporate having perpetual succession and common seal invites Electronic bids from the well reputed firms/suppliers/manufactures Registered with income Tax and Sale Tax departments and who are on Active Taxpayers List of the Federal Board of Revenue for supply of following Medicines / Lab items for the year 2024-25 to Cantt General Hospital Peshawar Cantt. - (1) The financial bidding will be online through E-bidding system. Tender form and BOQ can be filled online and downloaded from the official website of Cantonment Board Peshawar i.e. www.etender.mlc.gov.pk
- (2) All bidders are required to have valid GST, NTN & STRN.
- (3) **Local Purchase of Medicine Only** - For Local purchase of medicine, chemist / druggist working / having branch in Peshawar Cantt having medicine of value equal to 2.0 million at the time of submission of bid, shall participate only. Successful bidder shall enclose copy of license in the name of shop owner. The chemist / druggist shall offer rebate / discounted rate on retail price of local purchase of medicine (the rate of rebate / discount shall be clearly mentioned in digits percentage).
- (4) The successful bidder shall continue to supply medicine during contract period 2024-25 and even after expiry of contract on same approved rates till completion of tendering proceedings for next FY year.
- (5) The successful bidder shall supply quality medicine and CBP can test the supplied medicine from lab any time. In case of supply of substandard items / medicine, the contract shall be cancelled.
- (6) The bidder shall submit through Courier/Contractor Representative. 5% bid security sealed in envelop of the estimated cost for serial 1 and 2 above; and Rs. 50,000/- for serial no. 3 above, in shape of call deposit (Original) from scheduled bank before closing date and time.
- (7) The tender shall be cast in electronically on 14 Nov, 2024 upto 1100 hours and shall be opened on the same day at 1130 hours in the presence of tenderers or their authorized representatives, who may like to be present.
- (8) Conditional tender and tender without call deposit shall not be entertained.
- (9) Cantonment Board Peshawar reserves the right to demand the analysis of the quoted rates from the concerned bidder, to check their reasonability and workability.
- (10) The quoted rates shall be valid till the completion of work and in any case no escalation shall admissible on any pretext.
- (11) All Govt. taxes shall be deducted from the bill as per rules.
