2. Which are approved / registered by Pakistan Engineering Council from contractor which must be renewed for the year 2024-25 with Category C-6 having specialization code (EE-04 and EE-05). The contractor is bound to produce the documents in original & all copies must be duly attested including CNIC of the Contractor / Managing Partner / Director of the firm.
