
SCOPE OF WORK

1. INTRODUCTION: PIA intends to construct Maintenance Pits at TGS Parking Area & Procure New Porta Cabins for TGS and Engineering AlIAP Lahore

A) Construction of Maintenance PIT

A maintenance pit is required to be constructed at the TGS Parking Area to enable immediate maintenance of ground support vehicles on-site.

Technical Drawings & Site Plan is as follows,







- **B) PROCUREMENT OF NEW AIR-CONDITIONED PORTA CABIN**. This facility will serve as a temporary office and workspace for maintenance personnel. 02 porta cabin needs to be procured for the following areas,
- 1. TGS
- 2. ENGINEERING
