- Tender shall be sent under sealed cover which should reach to the undersigned by 05.05.2025 at 11.00 a.m. The tender will be opened on the same day at 11.30 a.m. in the presence of the tenderers or their authorized representatives who may like to attend. The bidding firms are required to enclose photo copy of PCP receipt regarding purchase of tender alongwith their sealed offers/bids.
- The tender must be accompanied with Call Deposit/Pay Order/Demand Draft of
 Rs.500,000/- (Rupees five lac only) as earnest/security money in favor of the
 Manager, Printing Corporation of Pakistan Press, Islamabad which shall be refunded
 on successful completion of the job.
- The offer should be valid for 90 days from the date of opening of tender.
- The rates may be given on the basis of "AS IS WHERE IS" for Waste Paper, used
