 The Utility Stores Corporation of Pakistan (USCP) Ministry of Industries & Production invites sealed bid/offers under Rule 36 (a) of the Public Procurement Rule, 2004 through E-Pads for hiring the services of making of Poly/Shopping bags (Printed) and deliver to all USC Regional Warehouses as per specification given below.

- 2. The participating Contractors/Manufacturers/Suppliers /Firms should be registered with Sales Tax and Income Tax department (valid NTN and STRN and in the active taxpayers' list of the Federal Board of Revenue (FBR) at the time of opening of bids and having minimum / at least three years relevant experience. The rates must be quoted per Kilo grams (Kg) on prescribed tender form containing terms and conditions/specification. The estimated 2% Bid Security of tender is enclosed as Annex"F".
- 3. Bids should be submitted electronically only through E-PADS under Rule 36 (a) "single stage one envelope" of the Public Procurement Rule, 2004, Manual submission of bids is not allowed.
- 4. The bids prepared in accordance with the instruction in the bidding documents, must be submitted on E-PADS on 13 May 2025 at 01:30 PM which will be opened on the same day at 02;00 PM though E-PADS. In case of opening of bids falls on local/national holiday, the date of bid closing/opening shall be the next working day on the same time and venue.
- 5. The bidders are required to give their best and a final price on EPADs (inclusive of all applicable Taxes) as no negotiations is allowed. Bids which are incomplete/not signed/not stamped/late or submitted by other than specified mode will be rejected. The contract will be awarded to the most advantageous bid on item wise lowest basis.
- 6. Bidding/tender documents along with terms and conditions etc., for bidding can be downloaded from USCP website i.e. www.usc.org.pk as well as E-PADS-PPRA website www.eprocure.gov.pk free of cost. Bidders need to register at E-PADS PPRA to access the tender documents and other relevant information.
- 7. An affidavit on legal stamp paper worth Rs.100/- to the effect that the Bidder has not been blacklisted by any Government/Semi Government/autonomous Organisation and there is no litigation lying pending adjudication in any Court of Law.
