PARC-Southern zone Agricultural Research Centre, Karachi as per relevant rules/regulations and Govt. policy invites sealed bids for procurement & installation of Lab & Research equipment from the GST Registered firms/suppliers, companies at PARC-SARC office Karachi under ALP Project titled on **“Surveillance and Integrated management approaches of root knot Nematode and root infected fungi associated with Okra & Brinjal”** during fiscal year 2023-2024. The firms, companies those registered with income tax and sale tax department, GoP and having good set up, relevant managerial experience in supplies with qualitative work performance are invited to quote their rates/bids for each equipment to be delivered /supplied at PARC-SARC, University of Karachi ,9 & 10, old block University Campus, Karachi (Postal code: 75270) Karachi in fiscal year 2023-2024.

2. The firms/companies, distributors' those authorized and capable (and not involved in litigation and legal inquiry) with PARC or any other department/organization may bid/quote their rates as per terms & conditions and generic technical specifications mentioned in the tender document. The tender document/ detail specifications can be purchased by the interested firms/suppliers from PARC-SARC Karachi (Procurement Section, A&GS) on any working day during office timings Monday to Friday from 28-05-2024 on written request of the firm/company letter pad with firm/supplier registration certificate and GST/NTN valid number, active tax payer list (ATL) along with pay order/bank draft amounting to Rs.1000/- (Non-Refundable) drawn in favor of Director General, PARC-SARC, Karachi”

3. Bidders who fulfill and abide by prescribed terms and conditions given in tender document may submit their technical and financial bids as per prescribed format separately in sealed envelopes in A&GS (Procurement Section), PARC-SARC, Karachi University Campus, Karachi. The bids will be received on or before 04-06-2024 up to 11.00 hrs. and will be opened by the tender committee on the same day (04-06-2024) at 11.30 hrs. at PARC-SARC (CDRI) Karachi in the presence of bidders or their nominated representatives who choose to be present. No tender document will be sold on date of opening of tenders. The quoted rates/bids shall remain valid up to 31-12-2024 and the supplies will be completed as per period/time mentioned in the purchase order (before 30-6-2024) by the qualified/ successful firm/suppliers leaving margin for payment process against the completed supplies within financial year 2023-2024.

4. Each bid should be accompanied with 2% earnest money of quoted bid amount in shape of bank draft or pay order (Cheque will not be accepted) in favor of “Director General, PARC-SARC, Karachi”. The conditional bids or those without earnest money or containing less earnest money /CDR shall not be accepted as per PPRA rules. The quoted prices should include with applicable taxes/GST (where applicable) as per Government policy.

5. The payment of all taxes/duties is the responsibility of the concerned firms /participating companies. PARC-SARC reserves the right to reject all bids proposal at any-time prior to the acceptance of bids or proposal in accordance with the provision of PPRA rules. However, PARC-SARC Karachi shall upon request communicate to any bidder, the ground for its rejection of bids or proposals but is not required to justify those grounds. Moreover, PARC-SARC may decrease or increase the quantity of tender items and also may change, add, omit the quantity, technical requirement or any instructions, condition of this tender in accordance with the requirement.
