04. Firms / Contractors borne on approved list 'D' of MES Contractors or the Government departments having experience of this type of work may only apply. The contractors will also furnish valid registration certificate of Pakistan Engineering Council, Bank Statement / GST and NTN certificate.

05. Contractors who desire may be present at the time of opening of tenders.

06. Bidding documents will be available in this office after of publications of this tender notice.

07. The accepting officer reserves the right to accept or reject the tender. Rejected tenders will be dealt with as per pare 33 (1) of PPRA Rules.
