- 2. The tender documents can be submitted with 4% earnest money of the bid value (including taxes) in shape of pay order/demand draft in favor of "National Agricultural Research Centre", Islamabad. Previous earnest money (if any) will not be considered for this tender. The tender of any firm/bidder who does not enclose the earnest money with the bid will not be considered.
- 3. The supply/work order will be issued upon the successful bidder/firm after completion of all the codal formalities.
- 4. The competent authority is not bound to purchase all the items in full quantity of any item mentioned in the tender document. Authority may issue supply/work order either for less or more quantity as per requirement of the concerned project.
- 5. A fresh certificate with regard to the financial position of the firm from its banker should be attached with the quotation to assess the financial capability of the firm.
