Bid documents will be sold out for whole Circle not for separate Division/Sub Division.

5. Call Deposit Receipt (CDR) for Rs. 500,000/- (Five Lac Only) will be submitted with bidding document (refundable) issued by a scheduled bank in Pakistan with the condition that if they are succeeded then they will not refuse to start the work and if they failed to start the work then Earnest money will not be refunded.

6. Successful bidders shall deposit Surety Bond/Bank Guarantee of Rs. 200,000/- (Two Lac Only) for one Sub Division issued by a Scheduled Bank in Pakistan or foreign Bank duly counter guarantee by scheduled Bank in Pakistan or an insurance company having at least A+ rating PACRA/ JCR for contract period.

7. The firms/contractors/courier services will submit an affidavit at the time of obtaining tender documents regarding non-blacklisting of company by any of DISCOs/ Govt. Department and no any litigation regarding any aspect against any department is underway in any court of law.

8. All the proceedings of the tender will be observed according to PPRA rules.

9. The applicant should provide manpower detail and academic qualification of key personnel, original bank statement of last one year with closing balance Rs. 4.00 million for financial soundness. Bank statement may not be 15-days

10. The security amount will be returned to the contractor on successfully completion of works, otherwise

earnest money i.e. 5 Lac will be forfeited.

11. The Department/Company may reject all bids or proposal at any time prior to the acceptance of a bid or proposal as per clause 33 "Rejection of bids" under PPRA Rule.
