

The Islamic Republic of Pakistan has received financing from the Asian Development Bank (ADB) toward the cost of **Power Distribution Strengthening Project**, and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The Lahore Electric Supply Company Limited ("LESCO or the Purchaser") invites sealed bids from eligible Bidders for the following Procurement in eight (8) lots. The Bidder shall quote for the entire quantity of any lot.

3. Open competitive bidding (international advertisement) will be conducted in accordance with ADB's **Single-Stage: One-Envelope** procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:
  - a) The Bidder or its proposed Manufacturer must have at least 05 years design / manufacturing experience of similar Goods of the respective Lots with similar or higher rating and capacity.

- b) The Bidder or its proposed Manufacturer shall have manufactured and supplied similar Goods of similar or higher rating and capacity in the quantities at least equal to the 100% quantities during the last ten (10) years in a single or multiple contracts. The Goods supplied by the bidder should have been in satisfactory operation for a continuous period of at least three (3) years on the date of bid opening for Lots 1-6 & of at least One (01) year on the date of bid opening for Lots 7-8. In case of JV, all partners combined should fulfill this requirement (draft JV agreement should be provided with the bid). The bidders, who are not manufacturers themselves, shall furnish an authorization from the concerned manufacturer to submit a bid for supply of their Goods to LESCO in Pakistan against this bid.
- c) The bidder should have sound financial status. In order to determine the same the manufacturer/supplier shall provide its up to date financial statements i.e. audited balance sheet, income statement, and cash flow statements for the last three (3) years. The difference between cash in hand and short-term liabilities should be adequate enough for smooth execution of the subject contract. The bidder's net worth calculated as a difference between total assets and total liabilities must be positive for last 03 (three) years. In this context the bidder is required to fill in the relevant forms given in Section-IV of the bidding document and submit the same with the bid.
- d) For the complete eligibility and qualification requirements, bidders should refer to the Bidding Document.
