The tender documents will be issued to Original manufactures / Authorized distributors / General Order Suppliers who are on Active Tax Payer List (ATL) for FBR and having Sales Tax Registration Number (STRN) registered with Income Tax and Sales Tax Department

Bids should be submitted in sealed envelopes, delivered at the **O/O Director (C&P), TDP, WAPDA Tarbela** by **15.04.2025** upto to **1100 hours** and must be accompanied by a Bid Security in an amount not less than **two percent (2%)** of the total Bid Price in currency of Bid in the form of unconditional Bank Guarantee (on prescribed form of Bid Security in the tender document) or in the form of **CDR** in favor of **GM & PD, Tarbela Dam Project**.

Bids will be opened on the same day at **1130 hours**, in the presence of the bidders or their authorized representatives who choose to attend at the **O/O Director (C&P), TDP, WAPDA Tarbela**

This procurement will be carried out as per PPRA rules, 2004 as amended from time to time.

The Employer reserves the right to accept or reject any or all bids or proposals at any time prior to acceptance of bid or proposal.

Note: The Bidder must meet with the following Qualification Criteria: -

In addition to the following key requirements, the eligible bidders are required to strictly meet with the post-qualification criteria given in the Bidding Documents.

- i. General Experience: 04 Years.
- ii. Specific Experience: One or more similar nature assignment substantially completed with contract price upto 2 Million or more during last 4 years. Also provide completion/substantial completion certificate from employer.
- iii. Black listed contractor/Firms/Supplier/Manufacture & defaulter are forbidden to submit bids on the basis of available information with WAPDA.
- iv. WAPDA will not be responsible for any type of tax/levy imposed by Federal/Provincial during the period of supply.
