1. The interested contractors shall submit an application on letter head along with PEC certificate & copy of pay order/draft for issuance of tender fee voucher up to **4th June 2024**.
2. Tender fee voucher will be issued till **4th June 2024** on submission of application.
3. The rates shall be quoted on or before **5th June 2024** upto **1200 hrs.** and shall be opened on same day at 1230 hrs. electronically on the portal. The contractors will be able to see the evaluation report online.
4. E-Tender without attachment of call deposit and Tender Fee voucher in favor of the undersigned will be reject.
5. The rates shall be quoted on MES Schedule of Rates 2021 (s amended up to date) on percentage basis.
6. The Cantonment Board Pano Aqil reserves the right to demand the rate analysis in accordance with the quoted rates from consented bidder, if required.
7. Tenders without earnest money (in shape of pay order/draft) will not entertained.

8. In case of the lowest tendered rates seems less the reasonable rate, the lowest bidder shall have to deposit standing security (refundable after successful completion of the work) @ 10% of estimated cost in the shape of call deposit within 07-days. In case of failure, the already deposited 2% earnest money shall be forfeited and tender will be cancelled.

9. The tender forms shall be issued as per relevant specialization code, category, criteria as mentioned in PEC's certificate of consumed contractor/firm.

10. No escalation in rates will be entertained at any stage.

11. The Cantt Board Pano Aqil Shall not be responsible to supply any kind of material and machinery to the contractors.

12. Conditional/ Incomplete tenders wherein necessary details are missing will not be accepted.

13. Successful contractors shall have to execute an agreement (at Their own cost) on non-judicial stamp paper of appropriate value for faithful execution of contract.


14. To complete the work within the targeted time period the successful contractors may be asked to execute the work in 03 x shift of (08 hours each) and the contractors be bound to comply. In case of failure on part of the contractor to comply with time line fine shall be imposed on defaulting contractor to be deducted from his payment, besides initiation of stern punitive action, which may lead to black listing.
