

 - A firm/contractor/supplier may offer tenders for one or more or for all categories.
 - The sealed envelope of tenders must contain the following documents, without which the tenderer will be liable to be rejected:
 - Tender on the Firm's letter paid with vendor number.
 - Call deposit worth to **Rs.20000/-** from a scheduled bank.
 - The rates of items if not covered in the "Tender Form" will be determined in accordance with the retail price fixed by the Chairmen Price Control Committee Skardu.
 - Government taxes applicable (if any) will be borne by the Firm/Contractor/Supplier.

Note: The Procuring agency may reject any or all bids at any time prior to the acceptance of a tender under the provision of PPRA Rules.
