Federal Government Employees Housing Authority (FGEHA), Karachi Office invites sealed proposals from Engineering Consultant firms having national/international repute for "**DESIGNING, PROCUREMENT AND DETAILED CONSTRUCTION SUPERVISION OF INFRASTRUTURE DEVELOPMENT WORKS OF SECTOR 24-B, SECTOR 25-B, SECTOR 18-C, SECTOR 19-C AND SECTOR 4-C AT KDA SCHEME-33, GULZAR-E-HIJRI, KARACHI**". The Firm must have adequate experience of planning, designing and detailed construction supervision of infrastructure development works.

The interested firms must have valid registration with PEC in the fields of specialization 1203 & 1204 alongwith valid Income Tax/Sales Tax registration with FBR. The envelope of "**FINANCIAL PROPOSAL**" must be accompanied with minimum **01%** of quoted amount as **Bid Security** in the form of Deposit at Call in favor of Federal Government Employees Housing Authority, with an undertaking in Technical Proposal, that the Financial Bid is accompanied with the requisite Bid Security.

Partial and incomplete Bids will not be considered. 'Technical Proposal' and 'Financial Proposal' are to be submitted at the address mentioned below by **25-08-2020 at 1100 Hrs**. The envelopes containing Technical Proposals shall be opened on the same date at **1130 Hrs** in the presence of authorized representative of consultants who choose to attend. Proposals received after the prescribed time and date shall be rejected.

All the applicable Federal/Provincial taxes must be considered while preparing the Financial Proposal and are required to be built in the quoted rates and not be mentioned separately. The bidders providing fake, forged, unsubstantiated and false information shall be liable to legal actions i.e. disqualification and blacklisting.
