AUCTION NOTICE

Cantonment Board Jhelum intends to auction sites for installing Electric / LED steamers at various places in Cantonment area. All the interested persons / firms / companies are hereby invited to take part in the open public auction which will be held on Sep, 2024 in the premises of this office. In case fruitful result does not come in the 1st attempt, then 2nd attempt will be held on Sep, 2024 and 3rd attempt will also be held on Sep, 2024.

TERMS & CONDITIONS

- i. Defaulters of any Government Organization particularly Cantt Board Jhelum are ineligible to participate in the auction.
- ii. Interested firms / companies must be registered with the Income Tax and Sales Tax Departments.
- iii. Every participant will have to deposit the Earnest Money @ Rs. 5,00,000/- in order to participate in the bid / auction of Electric LED / SMD Steamers.
- iv. Representative of the firm shall possess CNIC and proper authority letter in original to participate in the auction.
- v. Successful bidder shall deposit 25% of highest bid including earnest money at the fall of hammer in shape of crossed cheque and shall provide pay order on the next working day in lieu of 25% of highest bid and the submitted cheque will be returned accordingly. Failure of compliance to this condition will lead to forfeiture of the security deposit/ amount.
- vi. Balance amount of the highest bid i.e. 75% shall be deposited after the final approval of the Board, in three equal installments i.e. quarterly. Three post dated cheques of equal value of 75% of the highest bid shall also be provided by the successful / highest bidder.
- vii. The successful bidder shall be bound to execute written agreement with the Cantonment Board before installation of digital streamers
- viii. The successful bidder shall install digital streamers on the auctioned sites on his own expense and shall have to get electric connection installed at his own expense / cost from IESCO after obtaining NOC from CB Jhelum.
- ix. The successful bidder after the installation of the structure and before displaying of video / commercial shall submit structure and foundation stability certificate by a qualified structural engineer registered with Pakistan Engineering Council that the structure can bear the wind storm of upto the speed of 160 Km per hour.
- x. The maximum height of the digital streamers should remain as to be determined by the CB Jhelum.
- xi. Income Tax or any other tax, if levied by the FBR / Federal Government, on auction shall be deposited by the successful bidder.
- xii. Auction of advertisement rights shall be for a period of one year only from the date of approval of bid and subject to any other condition/s imposed by the board (extendable for two similar terms if the Board so decides on increase as decided by the board).
- xiii. The advertiser shall display National Videos on the occasion of 23rd March, 14° August, 06* September, Eid ul Azha and other events of national and international significance, whenever desired by the Board / CEO and in this regard no payment / waiver shall be given to the advertiser.
- xiv. If display of videos is blocked due to nonpayment of dues or any other fault at the part of the advertiser, no waive off shall be granted to the advertiser for that particular period.
- xv. Any information pertaining to the subject work can be obtained from the Office of the Cantonment Board Jhelum at any working day during office hours.
