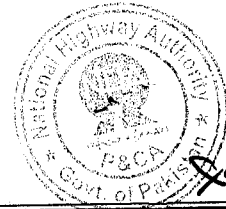

Section: I Dualization of road from Gatto Rora to adda Dharam Kot (30 Km) including link to Motorway (3.40 Km) (a stretch of 7 Km of this section is already dualized which will be evaluated during Feasibility Study (Distt Sialkot)

Section: II Evaluation and Dualization of Existing Road from Dharam KOT to Kamoke (31.7 Km) (Distt Gujranwala)

1. The National Highway Authority intends to hire/ engage a Consultant (Engineering Organization/ Firm) for “*Consultancy Services for Feasibility Study (Techno Economic Feasibility) & Detailed Design for Dualization of Sialkot Eminabad Road Upto Kamoki Including Link to Motorway Length: 65.10 Km (including Section-I &II).*”
2. Proposals are invited from reputable Consultants (Engineering Organizations/ Firms) having valid Pakistan Engineering Council (PEC) registration certificate in relevant field alongwith enlistment on active Tax Payer List of Federal Board of Revenue and the detail eligibility criteria mentioned in the RFP documents.

4. Pre-Proposal Conference will be held on **13th January, 2025 at 1100 hours** in the office of General Manager (P&CA), National Highway Authority, Islamabad.
5. Procurement will be carried out by adopting “Single Stage Two Envelops” procedure.
