### **INVITATION TO BIDS**

### PROCUREMENT OF "SUPPLY, INSTALLATION & MAINTENANCE OF STRONG ROOM DOORS AT VARIOUS OFFICES OF STATE BANK OF PAKISTAN BANKING SERVICES CORPORATION (SBP BSC)

- State Bank of Pakistan Banking Services Corporation (SBP BSC) intends to undertake Procurement of "Supply, Installation & Maintenance of Strong Room Doors at Various Offices of State Bank of Pakistan Banking Services Corporation (SBP BSC). Sealed bids are invited from all eligible bidders registered with Income Tax and Sales Tax Departments and who are on Active Taxpayers List of the Federal Board of Revenue (Sales Tax and Income Tax), meeting inter alia following eligibility criteria:
  - a) Bidder must be Original Equipment Manufacturer (OEM) or authorized dealer/agent of the OEM dealing in Supply of Strong Room Doors.
  - b) Bidder in case of authorized dealer/agent of the OEM must be authorized by the OEM specifically for this procurement.
  - c) Bidder must offer Strong Room Doors of such an OEM which has successfully completed three (03) contracts of supply of at least Resistance Grade XI, EX and CD designated conforming to EN 1143-1 or its approved equivalent certification and Class D High Security Locks conforming to EN 1300 or its approved equivalent standard, to central banks/monetary authorities/governments during last 5 (five) years.
- 2. The contract shall be signed between the Bidder and SBP BSC. In case the bidder is other than OEM, the same shall be required to provide an OEM Guarantee as per form of OEM Guarantee annexed as "Appendix-9" in the bidding documents.

Bidding Documents containing detailed terms and conditions, etc. are available for the interested bidders free of cost and may be downloaded from <a href="https://www.sbp.org.pk/tenders/index2.asp">https://www.sbp.org.pk/tenders/index2.asp</a>. Bidding will be conducted under National Competitive Bidding Procedure specified in the Public Procurement Rules 2004 as per Rule-36(b), under Single stage two envelope procedure.
- 4. A Pre-Bid meeting will be held on 07-10-2024 at 03:30 PM either physically at below given address of the SBP BSC or virtually via Zoom Video Conferencing, for which link will be shared with bidders. Desired attendees may be required to intimate at (proc.engg.hok@sbp.org.pk) three (03) days prior to the pre-bid meeting. In-case Pre-Bid meeting is falling on public holiday, the same will be conducted on next working day at the same time and venue.
- 5. Any prospective bidder requiring any clarification(s) in respect of the Bidding Documents may notify the SBP BSC in writing within 28 days (i.e. by 10-10-2024) prior to the deadline for submission of bids. Clarifications sought after due date shall not be entertained. Copies of the Employer's response/addendum/corrigendum (if any) will be uploaded on employer's website, including a description of the enquiry but without identifying its source.
- 6. Project Site(s) survey may be conducted on the timelines provided in the Bid Data Sheet of the bidding documents.
- 7. The Bids prepared in accordance with the instructions in the bidding documents along with bid security amounting to PKR. 15,000,000/- in the shape as specified in bidding documents must reach to office of the undersigned on or before 07-11- 2024 till 02:30 PM (PST). Bids will be opened in the presence of bidder's representatives who choose to attend at 03:00 PM (PST) on same day in Meeting Room, Engineering Department, State Bank of Pakistan Banking Services Corporation, Head Office Karachi, Pakistan. In case opening date is falling on a public holiday, the bid will be opened on next working day at the same time and venue.
