Financial Proposals will be opened by Auction Committee of National School of Public Policy as per rules and regulations, on the same day i.e. **16-05-2025 at 11.30 hours** in the Presence of willing bidders/representative in National School of Public Policy, 87- Shahrah-e Quaid-e Azam, Opposite PC Hotel, The Mall, Lahore and result will be announced within 05 working days.
4. The registration number of the vehicle must be clearly mentioned on the separate envelope of each vehicle.
5. Incomplete or combined bid for more than one vehicle shall not be acceptable.
6. Application form can be purchased from Accounts Office of this Institute, on payment of Rs.500/- (**Non-refundable**)
7. The remaining amount by the successful bidder must be submitted within 07 days after the approval of the bid. Otherwise the bid security will be forfeited.
8. The successful bidder is responsible for transfer of vehicle at his own expenses, after which possession will be given to him.
9. The purchaser will be liable to pay applicable Govt. taxes on purchase of vehicle(s).
