- Pay order/Demand Draft Amounting to 25,000/- (Rupees Twenty Five Thousand Only) in favor of **General Manager (Balochistan-North) NHA Quetta** for each vehicle will be deposited by the participants along with copy of valid CNIC as Expression of interest/Token Money without depositing such PO/DD on person shall be allowed to participate in Public auction.
- Successful/highest bidder shall have to deposit 25% of the highest bid amount at the spot for each vehicle as earnest money (Non-refundable) falling which the bid shall be rejected token money of the bidder shall be forfeited and vehicle shall be presented again for auction at the end.
- The Successful/Highest Bidder shall deposit the remaining bid amount within **Ten (10) Days** after approval of the bid by competent authority, otherwise 5% of bid amount shall be charged as ground rent up to period of **15 days** and thereafter the whole amount will be forfeited.
- Public Auction will commence on **June 27, 2024 at 1200 Hours** at NHA Complex, Airport Road, Quetta by the respective committee in the presence of eligible bidders. Bidders will provide copy of valid CNIC Complete Address Email and Telephone/Cell Phone Number.
- Original Book/Excise File of vehicle at **Serial No. 1, 2 & 8 to 13** mentioned above inside table are not available and same will be auction subject to willingness of bidders to arrange the same at their own end.
- Remaining/Outstanding Token Tax etc. will be paid by the successful Bidder.
- Government Tax (s) (Whatsoever admissible) will be charged as per prevailing Federal Government Rules besides Bid price separately.
- The vehicles shall be handed over to successful/highest bidder after full payment, depositing of Taxes in FBR and after transfer of ownership from the concerned ETO/Motor Registration Authority.
- NHA Reserve the right to accept or reject any or all bids and to and or withdraw any vehicle before public auction.
- In case of nay dispute the decision of auction Committee shall be final and not challengeable in nay court of law.
