PRE-QUALIFICATION NOTICE FOR REPAIR/MAINTENANCE

File No. 3(1)/2024-GA. Sealed bids are invited from the Islamabad / Rawalpindi based firms having proper shops and telephone facility, duly registered with sales tax authorities along with vendor numbers for repair/maintenance of Photostat Machines, Computer, Printer, Fax Machine, Scanner, Electric Water Cooler, Air conditioners, IT Equipment's, Server, UT Firewall Routers, Networking, Vehicles, Motorcycle, Furniture/Fixture Items and all other Machinery equipments, during the Financial Year 2024-2025. Tender can be downloaded from the websites of Ministry of Law and Justice www.molaw.gov.pk and Public Procurement Regulatory Authority www.ppra.gov.pk.

The terms and conditions will be as under: -

- ▶ Interested parties may submit their bids for repair/maintenance of Photostat Machines, Computer, Printer, Fax Machine, Scanner, Electric Water Cooler, Air conditioners, IT Equipment's, Server, UT Firewall Routers, Networking, Vehicles, Motorcycle, Furniture/Fixture Items and all other Machinery equipment's within (15) days of uploading of this notice.
- ▶ Security worth to Rs.10,000/- (Rupees Ten Thousand only) for repair/maintenance of Photostat Machines, Computer, Printer, Fax Machine, Scanner, Telephone Exchange, Electric Water Cooler, Air conditioners, IT Equipment's, Server, UT Firewall Routers, Networking, Vehicles, Motorcycle, Furniture/Fixture Items and all other Machinery equipment's is required to be deposited in favour of Section Officer (GA) Ministry of Law and Justice. Security deposits will be released/refunded within a fortnight to unsuccessful bidders and in case of successful bidders after 30th June, 2025
- ▶ The Repair/Maintenance work will be valid up to 30th June, 2025. Sub-standard work will not be acceptable and defaulters will be proceeded under law, including blacklisting.
- ▶ Firms will be bound to depute full time representative to carry out the repair/maintenance round the clock even on short notices and on closed holidays throughout the financial year at their own transport in "S" block Pak-Secretariat Islamabad.
- ▶ The Tender Documents must accompany the following certificates.
 - ▶ Firms Registration Certificates.
 - ▶ NTN/STN
 - ▶ Vendor Number.
 - ▶ Bank Account Number.
- ▶ An owner of more than one firm can send bid only from one company.
- ▶ The firms are requested to furnish an affidavit on stamp paper valuing Rs.20/- that the firm is not blacklisted and has no dispute with any Government Organization (s).
- ▶ The Competent Authority reserves the right to accept or reject any tender by whole or partially with assigning proper justifications /deficiency (if any).
- ▶ The competent Authority also reserves the right to cancel the contract entirely during the currency of year if sub-standard work is found. The security amount will be forfeited and the firm will be blacklisted.
