AUCTION NOTICE

It is hereby notified for the information of general public that 29 x different kinds of green standing and fallen trees in various area at Jhelum Cantt (Details of trees with its kind could be obtained from ME-Section, Cantt Board Office, Jhelum during working hours) will be disposed off through open public auction scheduled to be held on 20-08-2024 at 1100 hours at Jhelum Cantt. However, if auction is not conducted or low bid is received on due date, the auction will be held again on the next date 21-08-2024 at 1100 hours. For further information regarding auction / trees checking, please contact Cantonment Board Office (ME-Section), Jhelum Cantt. The detail of terms and conditions are given below: -

CONDITIONS OF AUCTION

- Interested persons shall have to deposit Rs.50,000/- as token money before the auction in this office alongwith copy of CNIC. After auction, the token money will be returned except the successful bidder.
- 2. Without token money, no person /contractor shall be allowed to participate in the auction.
- The highest bidder shall have to deposit 1/4th of bid at the fall of hammer and the balance amount will have to deposited within seven 07 days from the receipt of approval from the Competent Authority.
- 4. In case the balance amount of bid is not deposited by the successful bidder within prescribed period, the 1/4th bid money already deposited by him will be forfeited in favour of Government and trees will be put to re-auction at his risk and cost.
- The successful bidder shall deposit 10% of total bid money as advance Income Tax at the time of depositing of balance amount.
- 6. The highest bidder shall deposit 1/4th of bid as security with this office before issuance of permit which will be refunded to the highest bidder after the trees are removed and sites leveled without any loss to the Government property or private property.
- 7. The successful bidder shall not be allowed to sell the timber before removing it from the site.
- 8. The successful bidder shall be responsible for any damage caused by him to Government/ Private property during the removal of trees and the successful bidder shall have to pay full amount of damage.
- 9. The successful bidder shall not transfer the rights to any person through affidavit.
- 10. The trees shall not be cut during night or public holiday or without presence of rep of this office, failing which the permit shall be cancelled and trees will be re-auctioned with / without notice to the highest bidder.

- 11. If the trees are not removed within prescribed period, cost of wood/ trees already deposited shall be forfeited to Government fund and trees shall be disposed by the Government as deemed fit without any compensation to original bidder.
- 12. The undersigned reserve the rights to reject any or all the bids without assigning any reason.
- The security deposited by the successful bidder shall be forfeited in case of breach of any condition of auction notice.
- 14. The details of trees to be auctioned or other information required, may be obtained from the office of the Cantt Board Office, ME-Section, Jhelum Cantt during working hours before the auction date.
- 15. Auction notice will be uploaded on PPRA website.
