TERMS AND CONDITIONS

The general term & conditions for Annual Repair / Maintenance and Original works will be as under: -

- Interested bidders can only submit their bids online through E-Tender Portal of ML& C Dept. (<u>https://etender.mlc.gov.pk</u>).
- 2) Contractors having valid NTN No, and registered with PEC in the relevant category & limit are eligible to apply.
- 3) The tenderer is bound to electronically submit verified and genuine documents as well as call deposit, if in case his documents are found altered / fake / bogus, the Cantonment Board is at liberty to initiate criminal proceeding by todging FIR in the basis of forgery/ fraud against the tenderer and he / his frim shall be blacklisted.
- 4) The cut off time for submission of online bids will be 1200 hrs dated <u>25/09/2024</u> and shall be opened on same day at 1400 hrs electronically on the portal. The contractors will be able to see the comparative statement online.
- 5) E-tenders without attachment of call deposit / bond in favor of the undersigned as earnest money will be rejected.
- 6) The CDR's/Bid Security/earnest money (fixed amount) uploaded online shall also be deposited (in original) in CBW office (CB Care Centre) on the same day prior to cut off time in shape of demand draft/CDR/Pay order before opening of bids as per PPRA Rule No.25. In case of failure the bidder shall not be qualified for bid opening and shall be liable to face the consequences of forfeiture and blacklisting for sabotaging the tendering process.
- 7) The bid security/earnest money of successful bidder will be refunded after expiry of defect liability period i.e. 01 year after completion of work OR successful completion of audit which ever later.
- 8) In case if the lowest bid is less than reasonable rates (15% below the ruling %age as circulated by E-in-C's, latest) the lowest bidder shall have to deposit performance guarantee (refundable after successful completion of the work) 8% of bid amount in the shape of Bank Guarantee from any Schedule Bank in Pakistan or insurance bond from reputed insurance company which shall be got approved from the CBW (in addition to

- earnest money) within 07 days after issuance of acceptance letter as per PPRA Rule,39. In case of failure the already deposited earnest money shall be forfeited and tender will be cancelled.
- 9) The Cantonment Board reserves the rights to demand the analysis of quoted rates to check their reasonability and workability.
- 10) The Cantonment Board reserve the right to reject (prior to approval) the tender as per PPRA's Rule No. 33 due to any reason thereof.
- 11) The quantum of work may increase / decrease as per PPRA Rules and lowest tenderer shall be bound to execute the work on similar rates / terms & conditions.
- 12) The validity of tender rates shall remain applicable for financially ear 2024-25.
- 13) The successful contractor shall enter into a prescribed agreement (at their own cost on non-judicial stamp paper) with the CB Wah within 07 days of issuance of acceptance letter.
- 14) The issuance of work order shall be subject to approval from Board / CFA.
- 15) Works will be executed as per availability of funds.
- 16) Any information regarding the E-Tender can be obtained from the office of undersigned during office hours. Furthermore, guidance tutorial has been uploaded on the portal.
- No cheque/cash will be acceptable on account of earnest money.
- Conditional/multi optional tender/quotation will not be accepted.
- 19) All PPRA Rules and Govt taxes (in vogue for the time being) are applicable.
- 20) Any tool/machinery kind of store / mobilization advance for execution of job will not be provided by CBW.
- 21) Escalation clause and secured advance are not applicable / admissible.
- 22) Overall rate of bid will be considered as lowest instead of single item rate.
- 23) Rates should be quoted on the basis of MES Schedule of Rates 2021 (amended up to date) for scheduled items and market rates for non-scheduled items.
- 24) The cost of making any test shall be borne by the contractor as per MES specification/requirement.

> CONTRACTOR REGISTRATION

Sing Up

Contractor must register himself through ML&C portal (https://entender.mlc.gov.pk) and click on "Sign In / Sign Up" Button for sign up by entering Login ID (must be unique), NTN Number, Company Name, Password, Confirm Password and Mobile Number. An OTP (One-time password) will be sent to the mobile number. Enter OTP and click Sign Up Button

o Sing In/Log In

 Contractor can view tender after sign-in by entering credential (login ID and Password). Provided while sign up.

Contractor Profile

 Contractor must complete the contractor profile in order to participate in the in the bidding process, which includes Company Profile, Registration Details, Work History, Team Profile and Documents Attachments then submit it for approval.

> E-BIDDING PROCESS

Contractor can bid on tender only if;

- Logged in to the ML&C E-Tendering System
- Approved / Registered contractor with Cantonment Board Wah
- Valid PEC Category. Code and License
- For submission of bid, contractor must provide CDR details, attach scan copy of CDR and submit.
- After submission of the bid, contractor can view the submitted bid on the dashboard.

OPENING OF THE BID

o On the day of opening of bid, contractor can view the comparative statement which shall be generated through the system.
