## TERMS & CONDITIONS:

- 1. The interested contractors shall submit an application on letter head alongwith PEC certificate & pay order/draft for issuance of tender fee voucher upto 14-10-2024
- 2. Tender fee voucher will be issued till 14-19-24 on submission of application.
- 3. The rates shall be quoted on or before 15-10-2024 upto 12:00 hrs and shall be opened on same day at 12:30 hrs electronically on the portal. The contractors will be able to see the evaluation report online.
- 4. E-Tenders without attachment of call deposit and Tender Fee voucher in favor of the undersigned will be rejected.
- 5. The rates shall be quoted on MES Schedule of Rates 2021 (as amended upto date) on percentage basis.
- 6. The Cantonment Board Nowshera reserves the right to demand the rate analysis in accordance with the quoted rates from concerned bidder, if required.

- 7. Tenders without earnest money (in shape of pay order/draft) will not be entertained.
- 8. In case of the lowest tendered rates seems less than the reasonable rates, the lowest bidder shall have to deposit standing security (refundable after successful completion of the work) @ 10% of estimated cost in the shape of call deposit within 07-days. In case of failure, the already deposited 2% earnest money shall be forfeited and tender will be cancelled.
- 9. The tender forms shall be issued as per relevant specialization code, category, criteria as mentioned in PEC's certificate of concerned contractor/firm
- 10. No escalation in rates will be entertained at any stage.
- 11. The Cantt Board Nowshera shall not be responsible to supply any kind of material and machinery to the contractors.
- 12. Conditional/Incomplete tenders wherein necessary details are missing will not be accepted.
- 13. Successful contractors shall have to execute an agreement (at their own cost) on non-judicial stamp paper of appropriate value for faithful execution of contract.
- 14. To complete the work within the targeted time period the successful contractor may be asked to execute the work in 03 x shifts of (08 hours each) and the contractor shall be bound to comply. In case of failure on part of the contractor to comply with time line, fine shall be imposed on defaulting contractor to be deducted from his payment, besides initiation of stern punitive action which may lead to black listing.
- 15. Work order will be issued after the approval of competent authority as well as availability of Funds.
- 16. Other information can be obtained during office hours from the office of Cantonment Board Nowshera.
- 17. Advertisement is also available on the PPRA website i.e.www.ppra.org.pk.
- 18. The Cantonment Board/ Cantonment Executive Officer reserves right to cancel the tender at any stage under rule 33(1) of PPRA Rules 2004.
