(Single Stage Single Envelope E-Bidding System)

Cantonment Board Lahore invites sealed bids from the original manufacture / authorized distributors / suppliers / contractor registered with Income Tax and Sales Tax Departments for the supply of medicines for Cantonment General Hospital, with maximum discount on Retail Price, as per following terms and conditions:-

TERMS AND CONDITIONS

- 1) Contract will be for one year starting from 01 / 11 / 2024 to 31 / 10 / 2025 and can be extended till finalized of new contract.
- 2) Bid document instruction and specification can be viewed / download from e-tender portal at (<https://etender.mlc.gov.pk>).
- 3) The bidder shall submit 2% Bid security of the estimated cost sealed in envelope in the shape of call deposit at (original) by hand or through courier before closing date & time.
- 4) The cutoff time for submission of online bids will be 1400 hrs dated 17 / 10 / 2024 and shall be opened on same day at 14:30 hrs electronically on the portal. The contractors will be able to see the comparative statement online.
- 5) No Manual tender shall be entertained.
- 6) Any information regarding the can be obtained from the office of undersigned, during office hours. Furthermore, guidance tutorial has been uploaded on the portal.
- 7) Income Tax / other taxes will be applied as per prevailing government rates.
- 8) The supplier should be required to supply medicines to Lahore Cantonment Board on demand and submit the bill to the Cantonment Executive Officer for payment.
- 9) At any time, if the price quoted in bills is found higher than the price approved by Ministry of Health, the contract will be terminated & security forfeited and legal action will be taken.
- 10) The approved contractor has to execute contract on non-judicial stamp paper within fifteen days from the receipt of approval of the Competent Authority.
- 11) The contractor will be responsible to supply medicine of standard quality and the brand as prescribed. Having sufficient remaining expiry shelf life. Punitive action will be taken as per law in case the supply is found to be substandard or spurious. Smuggled medicine and the preparation not registered with Ministry of Health will neither be stocked nor supplied.
- 12) The Cantonment Board / Executive Officer reserve the right to reject the tender as per PPRA's Rule No. 33 (I) due to any reason thereof.
- 13) The Cantonment Board reserves the rights to demand the analysis of quoted rates to check their reasonability and workability.
- 14) In case if the lowest bid is less than reasonable rates, the lowest bidder shall have to deposit standing security (refundable after successful completion of the work) reasonable amount decided by the undersigned in the shape of call deposit within 07

days. In case of failure the already deposited 2% earnest money shall be forfeited and tender will be cancelled.

- 15) Incomplete / disfiguring / overwriting / by hand / delayed bids shall be declared non-responsive.
- 16) Any bid received in the contravention of enabling provision of PPRA Rules, 2004 will be declared non responsive by the procuring entity.
