Applications are invited for pre-qualification / registration of reputable, well-experienced,

financially-sound and income tax registered firms / contractors with directorate of ration, Air Headquarters Islamabad for supply of ration items (Dry and Fresh including Fine Atta, Semolina, Vermicelli, Lentil Seeds, Bengal Gram Flour, Rice, Cooking Oil, Milk Powder, Sugar, Tea Leaves, Green Tea, Meat, Vegetables, Fruits, Squash, Salt, Ice, Fire Wood, Bread and Condiments etc) to Southern Air Command and PAF Bases of SAC.

Application form with necessary instructions are to be collected from the office of **Senior Staff Officer (Support & Air Defence), Headquarters Southern Air Command, PAF Karachi & O/c Catering Flight, PAF Bases** from **19 January, 2025** during working hours from 0900 hrs to 1400 hrs.

Interested parties may apply from **19 January, 2025 to 13 February, 2025** during working hours from 0900 hrs to 1400 hrs by providing the following information:

- Owners / partners name, address, telephone, mobile numbers and fax number of the company. The proprietor / owner / partner should be Pakistani National.
- Six months to one-year summary of their bank accounts.
- Profile of the company, status of the firm, whether proprietorship / partnership / public or private limited company. Partnership deed in case contractors are other than proprietary / limited / general order supplier.
- Proof of firm's registration in case of partnership / proprietary.
- Memorandum and articles of association in case of Ltd Company.
- Attested copy of CNIC of owner / partners of the company is to be attached with the application.
- Details of registration with major organizations along with detail of agreements / contracts.
- Bank certificate showing financial stability / status duly verified, name of bankers.
- Sales Tax and Income Tax registration certificate, details of Income Tax Returns and copy of Assessment / Payment of Income Tax, NTN and Professional Tax Certificate.
- Litigation details, if any.
- Affidavit regarding correctness of documents and information therein.
- Work experience with any Governmental institution specially Army/Navy
- Attested copy of Contractor's domicile certificate
- Any additional information related to the subject.

Applications duly marked with "Pre-Qualification / Registration of Local Suppliers / Contractors for Ration Items" in sealed envelope are to be submitted to Senior Staff Officer (Support & Air Defence) Headquarters Southern Air Command, PAF. Application received after due date (13 February, 2025) will not be entertained.
