



4. The bidders shall bid for complete scope of work as specified in BOQs. Incomplete bids or bids covering partial scope of work will be rejected.
5. All bids must be accompanied by a bid security in the shape of irrevocable CDR of the amount specified issued in favour of Ministry of Foreign Affairs, Islamabad.
6. Pre-bid meeting will be held on 11 February 2025 at 1100 Hours in Conference Room, 3rd floor, Agha Shahi Block, Ministry of Foreign Affairs, Islamabad.
