**Terms & Conditions**

- a) Vehicle can be inspected at 9:00 to 11:00 am w.e.f. 18<sup>th</sup> to 19<sup>th</sup> February, 2025. No objections on vehicle condition will be accepted later.
- b) Interested parties will have to deposit an amount of Rs.50, 000/- as earnest money (refundable) with Drawing & Disbursing Officer of M/O NHSR & C before taking part in the bidding in the form of pay order/bank draft. **Detail of the bidder be submitted/uploaded on EPADS as per Annex-I till the bid opening day.**
- c) After deposit of earnest money, token will be issued for participation in bidding.
- d) Bidders must bring their original National Identity Card and its attested copy.
- e) Successful bidder shall deposit 25% of the bid as earnest money through pay order/bank draft in favour of DDO, M/O NHSR & C within two days. This amount will be refundable upon submission of complete payment into the state Bank of Pakistan through challan (Form 32-A) and duly verified by Federal Treasury Office, Islamabad within ten days of the bid. Failure to submit total amount of the bid, will result in forfeiture of the earnest money i.e. 25 %.
- f) Successful bidders shall pay all the Government Taxes.
- g) Payment of outstanding token tax is the responsibility of the successful bidder.
- h) Vehicles will be delivered after full payment in the State Bank of Pakistan duly verified by Federal Treasury Office, Islamabad.
- i) Registration and related expenses are the bidder's responsibility.
- j) Actionable vehicles are non-returnable.
- k) Vehicles will only be sold if the highest bid exceeds the reserved price. **Reserve Price shall be announced on inspection days and also shall fix on the vehicles.**
- l) Competent Authority may reject all the bids before or after acceptance.
- m) Vehicles will be handed over after approval and complete payments.
