TERMS AND CONDITIONS:-

- Interested bidders can submit their bids only online through e-Tender Portal of ML&C Deptt (<https://etender.mlc.gov.pk>), Contractors having valid NTN No, CNIC No. and PEC Registration of relevant codes are eligible to apply with proper PEC registration / renewal. The cutoff time for submission of online bids will be 1200 hrs dated 14-11-2024 and shall be opened on same day at 1230 hrs electronically on the portal. The contractors will be able to see the comparative statement online.
- E-Tenders without attachment of call deposit/bid bond in favour of the undersigned equal to the earnest money will be rejected.
- The Cantonment board reserves the rights to demand the analysis of quoted rates to check their reasonability and workability.
- The successful contractor shall enter into prescribed agreement (at their own cost Rs. 0.35 Per each hundred Rupees of Estimated Cost of each project on non-judicial stamp paper) with the CB Jhelum within 07 days for the issuance of acceptance letter.
- The Cantonment Board / Executive Officer reserves the rights to reject the tender as per PPRA's Rule No.33 (1) due to any reason thereof.
- The issuance of work order shall be subject to approval from Board.
- The validity of tender rates shall be up to 180 days as per PPRA/PEC Rules.
- Any information regarding the e-tender can be obtained from the office of undersigned during office hours. Furthermore, user guidance tutorial has been uploaded on the portal.
- The contractors / bidders, who quoted their bids / rates more than 10% below the sanctioned estimate, shall submit performance guarantee equal to as decided by Cantt Board / Cantt Executive Officer under rule 39 of PPRA Rules 2004.
- Incomplete / Conditional / disfiguring / overwriting / by hand / delayed bids shall be declared non-responsive.
- Any bid received in the contravention of enabling provisions of PPRA Rules, 2004 will be declared non responsive by the procuring entity.
- Contractors / firms can participate after the deposit of tender fee as tabulated above, tender fee challan will be obtained by submission of request / application for issuance of Tender Fee Challan from Cantonment Board Office "Tufail Road" Jhelum Cantt after the publication of the invitation to bid.
- All applicable taxes levied by the Government including Income Tax will be deducted from the cost of work done at the time of payment.
