- Tender must be accompanied with Bank Guarantee mentioned in bidding documents in favor of Chief Executive Officer IESCO Islamabad valid for 120 days (One hundred & twenty days) in the form of Bank Guarantee/Call Deposit issued by any schedule Bank of Pakistan (having rating A+ or above). Moreover, Bid Security must be enclosed in Technical bid Envelope.
- Tender forms including terms and conditions can be obtained from the office of Material Management IESCO Islamabad against non-refundable amount of Rs.3000/- on any working day during office hours till a day earlier from the date of opening of tenders.
