Original sealed bids and earnest money in favour of DDO M/o Housing and works must be submitted to Room No. 5, Ground Floor, B-Block Pak Secretariat, and Islamabad on or before closing date and time.

Date and time for opening of Bids	On 23-01-2025 at 11:00 A.M through (EPADS) in the Committee Room of the Ministry of Housing & Works. Bids shall be opened in presence of bidders or their authorized representative.




