Sealed Tenders are invited as per PPRA procedure "Single Stage Single envelope" for the following development works on percentage basis on Pak PWD Schedule of rate 2022 from Pakistan Engineering Council Registered contractors/firms should also be registered with income tax Department and available on Active Taxpayers list of Federal Board of Revenue. The applications for tenders with the documents as per terms and conditions below well be received in the office of the undersigned during office hours on any working day up to **14-4-2023** and tender documents will be issued till **18-04-2023** after verification of documents. The individual applicants for each work should be submitted on written request at company's letterhead accompanied with attested copies of **CNIC, PEC, Firm Documents, NTN & Bid Security**. The tenders should reach in the office of undersigned on **19-04-2023** up to **11:30 PM** and will be opened on the same day at **12:30 PM** in the presence participants or their authorized representatives.

**TERMS AND CONDITIONS:**

1. Bid Security as mentioned below in the shape of CDR/Pay Order in favor of the Executive Engineer, Central Civil Division, D.I.Khan issued by any scheduled bank must be submitted at the time of purchase of bidding documents.
2. The applicant firm should have completed similar nature projects of the same quantum, within last three years. Documentary evidence to this effect in the shape of work order and completion certificate duly attested by the concerned Project Incharge with the application.
3. An affidavit on original judicial paper worth Rs. 100/- to the effect that the contractor/firm is not in any dispute/litigation with any Government Department is a mandatory requirement for issuance of tenders.
4. The Contractor/Firm have to provide documentary evidence of Account Maintenance Certificate by the Scheduled Bank.
5. The tenders would be issued only to the owner of the firm or his authorized representatives having legal Authority Letter/Power of Attorney.
6. No applications for issuance of tenders through E-mail, fax, Telex will be entertained.
7. No tender will be sold on the specific opening date.
8. Any information/clarification regarding details of work, specifications etc., can be seen in the office of the undersigned on any working day during office hours.
9. The submission of bid implies that the bidder is fully conversant with the nature of work, scope, site conditions applicable rules, Federal, Provincial and Local Taxes etc.
