INVITATION FOR PRE-QUALIFICATION

The Executive Engineer B&R Division GB C&WD Shigar has been entrusted by the government of Gilgit-Baltistan and provided funds to be Financed the cost of project namely "Construction of 210 ft Paju Wooden suspension bridge" to eligible payments under the contract for which this invitation for pre-qualification is issued.

- 2. The GB C&WD Shigar herein after the employer intends to pre-qualify constructors for the works under this project "Construction of 210 ft Paju Wooden suspension bridge" estimated cost is Rs. 66.053 million.
- Pre-qualification is open to constructors/ joints venture of constructors who are registered with PEC in relevant Category and code CE-02 (VI) Suspension bridge only for construction and operation of engineering works described in para 2 mentioned herein above. Proposals may be submitted for pre-qualification for the above work.
- Appropriate category of PEC registered constructors may obtain the prequalification documents from the office of the employer, at B&R Division GB C&WD Shigar on written request to the undersigned.
- 5. The request must clearly state "REQUEST FOR PRE-QUALIFICATION DOCUMENTS" for "Construction of 210 ft Paju Wooden suspension bridge". The documents are available for a non-refundable fee of Rs 6000/-.
- 6. The proposals for pre-qualification must reach in sealed envelopes to the Executive Engineer B&R Division GB C&WD Shigar on or before 21st June 2024 (Closing time 04:00 PM) and be clearly marked "APPLICATION FOR PRE-QUALIRIFCATION" for "Construction of 210 ft Paju Wooden suspension bridge". The proposal will be checked evaluated through committee and informed to pre-qualified contractors.
- 8. Applicants will be informed in due course of time about the result of the evaluation of proposals. Only the firms of constructors and joint ventures pre-qualified under this process will be invited to bid.
