

Islamic Republic Of Pakistan has received financing from World Bank towards the cost of Electricity Distribution Efficiency Improvement Project (EDEIP) and intends to apply part of the proceeds toward payments under the contract for "Supply Of 9000Nos Transformer Monitoring System (TMS) along with Related Services For Installation On Distribution Transformers Of 200KVA & 100KVA Ratings",
2. Multan Electric Power Company (MEPCO) now invites sealed Bids from eligible Bidders for 'Supply Of 9000Nos Transformer Monitoring System (TMS) along with Related Services For Installation on Distribution Transformers Of 200KVA & 100KVA Ratings'
3. Bidding will be conducted through **international competitive** procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" dated November 2020 and is open to all eligible Bidders as defined in the Procurement Regulations.
4. Interested eligible Bidders may obtain further information from the office of Chief Engineer (Development) PMU MEPCO Multan at the address below during office hours i.e. 0800Hrs to 1600 Hrs
5. The bidding document in English may be purchased by interested Bidders upon the submission of a written application on company's letter head to the below address and upon payment of a non-refundable fee of Rs. 5,000/- The method of payment will be by cashier's cheque / Bank draft from any scheduled bank of Pakistan in favor of the Chief Engineer (Development) PMU MEPCO or Cash Deposit Slip in HBL Branch Opposite MEPCO complex Multan Account Number: 09377900192303. The documents may be collected in person or would be sent by courier services for an additional amount of Rs. 500/- for domestic delivery. For international delivery, the documents could be sent by express airmail for an additional payment of US\$ 60. No liability will be accepted for loss or late delivery of the documents. No bidding document will be issued on the opening date.



6. Bids must be delivered to the address below by 11:00Hrs on June 05, 2024. Electronic Bidding will not be permitted. Late Bids will be rejected. The outer Bid envelopes marked "ORIGINAL BID", and the inner envelopes marked "TECHNICAL PART" will be publically opened in the presence of the Bidders' designated representatives and anyone who chooses to attend, at the address below on June 05, 2024 immediately after bid submission deadline. All envelopes marked "SECOND ENVELOPE: FINANCIAL PART" shall remain unopened and will be held in safe custody of the Purchaser until the second public opening.
7. All Bids must be accompanied by a "Bid Security" of amount at least US\$ 225,000/- (Two Hundred and twenty five thousand US Dollar) or at least PKR 63,450,000/- (sixty-three million four hundred fifty thousand Rupee only).
