In Proposal Data Sheet, Page No. 27, Sub-Clauses (iii) of Clause 21.1, may be read as "Specific experience (03 Projects/Assignments as Expert/Advisor on Periodic Inspection of Large dams / Hydropower Projects)" instead of "Specific experience (05 Projects/Assignments as Expert/Advisor on Periodic Inspection of Large dams / Hydropower Projects)".

In Proposal Data Sheet, Page No. 27, Sub-Clauses (iii) of Clause 21.1, may be read as "Specific experience in similar filed (of 15 years in Construction / Design / O&M of Large Dams / Hydropower Projects)" instead of "Specific experience in similar filed (of 15 years in Construction of Large Dams / Hydropower Projects)".

In Proposal Data Sheet, Page No. 25, Sub-Clauses 17.7 & 17.9, proposed submission deadline may be read as August 12, 2024, instead of August 05, 2024. Time and Venue of proposal submission / opening shall remain unchanged.
