

TENDER NOTICE
FOR PRE-QUALIFICATION OF FIRMS FOR THE SUPPLY OF TYRES
DURING FINANCIAL YEAR 2024-2025

A Federal Government Organization intends to enlist Peshawar based firms for supply of tyres for its vehicles during the current financial year **2024-2025**.

The interested firms can download terms & conditions alongwith list of tyres from the PPRA website www.ppra.org.pk.

Tender with a caption on envelopes i.e. "Tender for Tyre bids" & "to be opened by the addressee only" (i.e Chairman Purchase Committee) must reach to **PO Box No. 06, G.P.O, Peshawar Cantt** by **14-08-2024 at 11:00 am** & will be opened on the same day at **11:30 AM**.

TERMS & CONDITIONS:

- A) For pre-qualification, interested firms registered with income Tax / Sales Tax Departments must submit following documents: -
- a) Relevant experience & past performance.
 - b) Capabilities with respect to personnel, equipment & plat.
 - c) Financial position.
 - d) Appropriate managerial capability.
 - e) Stock position, capability to meet emergent demand.
- B) Only those firms / suppliers which fulfill the above criteria shall be pre-qualified.
- C) Only pre-qualified firms shall be entitled to participate in the tender (For which pre-qualified firms shall be informed separately).

The bids should accompany: -

- i. Copies of income tax & tax registration certificates, vendor number / account No. etc.
- ii. Certificate that firm is not black listed by any Govt: department.
- iii. The vendor must provide complete information about manufactures & certify that tyres are genuine & as per required specification. Tyres will be got checked, if required, before or after procurement. Warranty period on tyres & bills should also be mentioned.
- iv. Firms will submit complete list of different types & sizes of tyres as per advertised specification (especially imported tyres).
- v. Selected firms will remain on panel throughout the current financial year & they will have to provide tyres on short notice. Only the fresh & latest tyres shall be procured.
- vi. Firms having tyres of all the sizes from (S.No 1 to 13) shall be preferred.
- vii. Word "Tyre bids" must be written on the envelop.
- viii. All other terms & conditions as per PPRA Rules.
