 - iii. Enlistment the firm with the C&W Department GB.
 - iv. All bids may be accompanied by Bid Security 2% in shape of call deposit from any schedule bank of Pakistan in the name of the Executive Engineer C&W Department GB, B&R Division Diamer and must be delivered to the Superintending Engineer C&W Department Diamer Circle Office Diamer Astore on or before above mentioned date and time in the presence of bidders, representatives who choose to attend, at the same address.
- 4. The detail eligibility and qualification criteria for selection of consultancy services is given in RFP documents.
- 5. Proposals (Technical & Financial) should be complete in all respect in sealed envelopes and reach on or before **08.10.2024**.
