

# **INVITATION FOR BIDS**

1. The Embassy of Islamic Republic of Pakistan, Ankara, Türkiye, herein referred to as The Employer, invites sealed bids from eligible firms or persons possessing valid Müteahhitlik Yetki Belgesi (Contracting Authorization Certificate) issued by Türkiye Cumhuriyeti Çevre, Şehircilik ve İklim Değişikliği Bakanlığı (Republic of Türkiye Ministry of Environment, Urbanization and Climate Change).

The prospective bidder entity must have at least one architect and / or interior designer and / or civil engineer on its payroll and the same must be involved in the project as well, if awarded.

The bids are required for the redesigning, modification and renovation of part of Chancery Building of Pakistan Embassy Ankara, Türkiye.

- i. A written application (in English) from the bidder soliciting the bidding documents package while stating reference to this advertisement. The application must state the email on which the applicant wishes Bidding Documents to be sent.
- ii. A payment proof of deposit of a non-refundable amount of Two Thousand (2000) Turkish Lira (TL). - iii. Submission of copy of valid Müteahhitlik Yetki Belgesi (Contracting Authorization Certificate)

(Only one bid can be submitted against one payment for bidding documents package. The bid is to be submitted by the same firm / person whose Müteahhitlik Yetki Belgesi would be submitted while obtaining Bidding Documents package.)

After completion of above-mentioned steps, the prospective bidders may either acquire hard copy by visiting the embassy during working hours (with prior appointment), and / or the soft copy could be acquired through email.

3. For the interested bidders who would have completed steps stated vide para 2 above, a site visit will be arranged on 04<sup>th</sup> October, 2024. One rep from those firms / persons will be eligible for the site visit who would have completed the steps mentioned vide para 2, latest by 03<sup>rd</sup> October, 2024.

4. All bids must be accompanied by a refundable Bid Security in the amount of Forty Five Thousand (45000) TL. No bid will be considered without submitted Bid Security.

5. The sealed complete bid documents must be delivered by hand or registered mail or courier to the address given below, at or before 1100 hrs on 17<sup>th</sup> October, 2024

6. Bids will be opened at 1400 hours on the same day in the presence of bidder(s) representative(s) who choose to attend, at the same address.
