

REQUEST FOR PROPOSAL

Proposal No: IESCO/P&E/CONSULTANT/RFP-04/2024

1. IESCO intends to invite sealed proposals to submit a technical and a financial proposal for consultancy services required for the **HIRING OF CONSULTANTANCY SERVICES FOR “System Augmentation Program (SAP) (HT/LT) Safety Hazard And Rural Electrification Project (REP)” IN IESCO.** Your proposal could form the basis for future negotiations and ultimately a contract between your firm and the Client named in the Data Sheet i.e. Islamabad Electric Supply Company (IESCO).
2. Firm must be registered with Pakistan Engineering council in relevant code, FBR. Firm must demonstrate Active Tax Payer for the purpose and firm must submit three years returns. In case consulting firms participating in JV then both partners must meet the criteria.
3. A brief description of the assignment and its objectives are given in Terms of Reference (TORs) in RFP and RFP is uploaded on IESCO website in pdf.
4. The Assignment shall be implemented in accordance with the completion schedule given in the Section-VI
5. The Client i.e. Islamabad Electric Supply Company (IESCO) funds for the project provided in the annual budget for *FY 2024-2025 and FY 2025-2026* for utilization towards the cost of the Assignment, and the Client intends to apply part of the funds to eligible payments under the contract.

7. RFP shall be accompanied with Bid Security amounting Rs. 1,000,000/- in favor of Chief Executive Officer (CEO) IESCO, Islamabad in shape of Bank Guarantee /DD/CDR valid for 28 days beyond bid validity period and Bid Validity is **150** Days.
