The tender documents will be issued on production of PEC Registration Certificate & Income Tax Registration Certificate etc.

Bids should be submitted in sealed envelopes, delivered to the **office of Dir (C&P), Tarbela Dam Project** by **20.02.2025 up to 1100 Hours** and must be accompanied by a Bid Security in an amount not less than **Rs. 40,000/-** in the form of unconditional Bank Guarantee (on prescribed form of bid security in the tender document) or in the form of CDR.

Bids will be opened on the same day at 1130 hours in the presence of the bidder or their authorized representatives who choose to attend at the **office of Dir (C&P), Tarbela Dam Project**.

This procurement will be carried out as per PPRA rules, 2004. (Single stage one envelope) as amended from time to time.

The employer reserves the rights to accept or reject any or all bids or proposals at any time prior to acceptance of a bid or proposal.

**Note: The Bidder must meet with the following Qualification Criteria:-**

1. General Experience = 4 years
2. Specific Experience = One or more similar nature assignment, substantially completed with contract price up to 2 Million or more during last 4 years. Also provide completion/substantial completion certificate from employer.
3. Black listed contractor/Firms/Supplier/Manufature & defaulter are forbidden to submit bids on the basis of available information with WAPDA.
4. WAPDA will not be responsible for any type of tax/levy imposed by Federal/Provincial during the period of supply.
