QUOTATIONS FOR HIRING OF SECURITY SERVICES/GUARDS

CB Nowshera being Procuring Entity invites sealed quotations from well reputed firms having valid registration with Govt. of KPK and other relevant Govt, agencies / departments having valid license of Ministry of Interior and are on Active Taxpayers List of the Federal Board of Revenue for the Hiring of Services of security guards with arms to be deployed for the security of various installations of CB Nowshera.

Terms & Conditions:-

1. The quotation will be deposited in tender box on 21st March-2025 at 1200 hours and will be opened on the same date at 12:30 hours in the presence of interested / participated firms and their authorized representative of firms who happen to be present at that time under rule 28(2) of PPRA Rules, 2004 (as amended upto date).
2. Well trained armed persons (Ex-servicemen) Security Guards required to be provided.
3. The Age of Security Guards must not be more than 45 years.
4. The Guard should be physically fit and dressed up properly in neat and clean uniform.
5. Security Guard must be security cleared and in possession of proper documents/police report/valid CNIC/Service Certificate etc.
6. For Security Gun/Shot Gun/ registered license armed shall be provided by security firms / agency along with wireless communication system.
7. All the Govt. Taxes (Federal, Provincial and others) will be deducted as per prevailing Government policy.
8. Interested security firms / companies are required to quote their rates on monthly salary basis for each guard.
9. The services shall be engaged for a period of 02 years, extendable for further 02 years on requirement basis. However, No. of security guards may vary as per requirements as per Rule 42 (c)(iv) of PPRA Rules, 2004 (as amended upto date).
10. The deployment shall be for 24 hours (on shift basis).
11. The quoted rates should be valid for 02 years.
12. 02% (Two percent) earnest money bid security of quoted cost must be accompanied in shape of call deposit in the name of CB Nowshera from any scheduled bank in accordance with Rule 25 of PPRA Rules, 2004 (as amended upto date). Any bid security not validated from bank can result into penal consequences.
13. Bidder blacklisted by CB Nowshera or involved in litigation are found to be indulged in corrupt or fraudulent practices will be considered non responsive by CB Nowshera being Procuring Entity.
14. The successful bidder shall be bound to execute an agreement with the Procuring Entity and all terms & conditions including in tender notice shall be binding on him.
15. Tender documents can be obtained from the office of the Cantonment Board Nowshera during the office hours on payment of Rs.1000/- (non-refundable) immediately after publication of this notice. Tender / bidding documents can also be downloaded from CBN website <http://nowshera.cantonment.gov.pk>.
16. Any bid received in the contravention of enabling provisions of PPRA Rules, 2004 will be declared non-responsive by the Procuring Entity. CB Nowshera being Procuring Entity reserves the right to accept or reject any tender / bid on administrative grounds under Rule 33 (1) PPRA Rules, 2004.
